3. Climate Statement from SAYMA

SAYMA has drafted a minute about Climate Change, that they hope to get approved sometime before the next COP meeting. The minute from SAYMA was reviewed in this business meeting.

Climate Statement

Southern Appalachian Yearly Meeting and Association (SAYMA)

The Religious Society of Friends witnesses to the truth of our times. In this moment, we recognize that we are facing an existential crisis that requires a response greater than individual actions. The systemic structures as well as the daily choices of peoples, governments and faith communities across the globe must act in radical concert to address the climate catastrophe we have created.

World leaders will come together for the Conference of the Parties to the United Nations Convention on Climate Change (COP29). SAYMA calls on them to acknowledge that the burning of fossil fuels is the primary cause of the climate crisis, and to recognize that many of the nations that are hardest hit by a warming climate have been the least responsible for the crisis and are least able to cope with the consequences. We call on COP29 to clearly state that the existential crisis of climate change requires more than merely an orderly transition. We must end our use of fossil fuels by 2030. We call on COP29 negotiators to commit to fully finance the Loss and Damage Fund to compensate developing countries, and the Green Climate Fund to implement renewable solutions in developing countries.

The continued burning of fossil fuels is destabilizing the climate, acidifying oceans, and destroying the natural systems that humans and all living creatures depend on. Friends in the Southern Appalachian region are guided by our query for Care of the Earth that asks "How do I hold in the Light the impact of climate change on the 'least of these,' the vulnerable members of the human, animal, and plant communities?"

Every Friend, household, and meeting in our community is asked to be responsive to this query and we all ask our neighbors around the world to take immediate and practical steps to reverse our dependence on fossil fuels and demonstrate a communal reverence for interdependent life.

This statement has been brought forward by SAYMA's Earth Justice Committee, which plays the essential role of helping SAYMA be accountable to our commitment. We acknowledge the work of Philadelphia Yearly Meeting and PYM's Climate Witness Stewards, from which we have drawn much of the language in this statement.

Concerns were expressed about the sentence "We must end our use of fossil fuels by 2030."

This sentence could be replaced with something like "We must strive to wean ourselves and our economies from dependence on fossil fuels as soon as possible."

Another suggestion: "We recognize the need to end our use of fossil fuels. We also recognize their ubiquity in our lives. We strive to take the difficult steps to end their use."

Some friends requested more time to reflect on this minute.

The co-clerks will bring suggested revisions to the next meeting for business.

4. Records of CFM Business Meeting Minutes

The acid-free copies (or any hard copies) can be printed from those electronic documents.

Catherine Reid volunteers to catch up on printing the paper copies.

Donna Idol and Barb Wulf will confirm that the website has a complete collection of minutes.

Lucy will start printing the meeting minutes going forward from now, with some guidance from the co-clerks.

September has historically been the time when archival minutes are sent to Guilford College.

5. Children returning to the meeting after worship

6. Animal Blessing

Children would be invited to participate, although First Day School could decide how best to handle that. Joanna will be clerking this event and will send out some guidelines ahead of time. Outdoor singing will start at 10:45 with worship beginning at 11.

Friends who would like to attend the traditional silent worship can meet at 9:45 on that Sunday.

This proposal is approved.

Ministry and Care will season this proposal and may bring back further details to the next MFWAB.

7. Funds for Richard Martin's Cuba trip

Richard Martin will be traveling soon to Cuba.

We approve \$100 expenditure from the Peace and Social Concerns Fund to reimburse Richard for purchases he has made of supplies requested by Havana Friends Meeting

Money could be granted from CFM travel funds to cover baggage fees to carry supplies for Havana Friends Meeting, but this can be approved separately by the Finance Committee.

The CFM Treasurer has said that there is additional funding available which can be requested for further donations to Havana Friends Meeting.

8. MFWAB meeting time

We are trying this new schedule of meeting two months on a Sunday morning and one month on a Monday evening, for six months. That will take us through May.

One friend pointed out a scheduling conflict which affects several CFM members on the 3rd Monday evening of the month. This friend hopes that when scheduling is next addressed in June, we can find an evening time that avoids this conflict.

9. Announcements

The Ministry and Care committee is currently drafting the state of the meeting report and it will be brought to CFM Business Meeting in March.

Catherine Reid has worked with Lisa Rose to make the job descriptions easier to find on the website.

Catherine Reid plans to start a book discussion group around the book *An Invitation to Quaker Eldering*. Interested persons can coordinate with Catherine.

The next Racial Equity Committee meeting is Feb 26 at 4:30. It will include members of the historically black Lincoln Park community.
